For the past year, the U.S. has been the largest source of foreign direct investment in Mexico, according to the latest figures from the National Institute of Statistics and Geography (Instituto Nacional de Estadística y Geografía, or INEGI). The U.S. accounted for 40.1% of all FDI in Mexico in 2010, up from 37.5% in 2009. The U.S. was followed by Japan at 11.4%, Germany at 7.8%, and the United Kingdom at 5.8%. The total value of FDI in Mexico reached \$100 billion in 2010, up from \$87.5 billion in 2009. The U.S. also remained the top destination for Mexican outward investment, accounting for 54.1% of all Mexican outward investment in 2010, up from 51.1% in 2009. Mexico's outward investment reached \$11.5 billion in 2010, up from \$10.5 billion in 2009.
