- (b) Secondary (Geographical) Segment Secondary segment reporting is on the basis of geographical locations of the customers. The company's revenue during the December, 2014 quarter by geoagraphical market are: Domestic Sales Rs. 1.61/ Crores and Export sales Rs. Nil.
- 5. Persuant to the notification of schedule II of the companies act' 2013 (the act), by the ministry of corporate affairs effective from 01.04.2014, the management has reassessed and changed wherever necessary the estimated useful life of its fixed assets generally in accordance with the provisions of schedule II to compute the depreciation as per the requirement of the act.

As per the transitional provision provided in 7(b) of Schedule II of the Companies Act, 2013, for those assets wherein the remaining useful life is Nil as at April 1, 2014 based on the revised specified life as per Schedule II of the Companies Act, 2013, the carrying value of such assets amounting to Rs. 13.00 Lacs after effect of salvage values as at April 1, 2014 has been adjusted against the Retained Earnings of the Company as at April 1, 2014.
