Why 2015 had record number of shark attacks

Feb 13: The numbers are in. 2015 set a record for shark attacks around the world with 98 incidents, including six human fatalities.

That total is 26 more than the previous year and 40 more than the figure from one decade prior.

According to the International Shark Attack File, the main drivers for the rise in incidents were warm water from El Niño and global warming (2015 was also the hottest year on record), a lack of severe storms in most developed countries and a relatively strong economy which sent more vacationers to the beach.

Those factors combined to put more people in the path of sharks, which prefer to avoid people and don't target them the way they do in B movies, says George Burgess, who compiled the report through his work at the Florida Museum of Natural History. The data also showed the US had 59 shark attacks, a new record, with particularly high activity in Florida and the Carolinas.
